## Committee Meeting Notes – 20<sup>th</sup> November 2019

**At the start of the meeting it was decided to only discuss Christmas Tree issues.**

**1. \*Anti-Social Behaviour (ASB)** Nothing reported.

**2. \*Treasurer's Report** Balance at bank £1937.61. Outstanding expenditure, lights for the treeless Christmas tree.

**3.\*SV Reservoir Issues** GM reported that a meeting was held between LRC and Dwr Cymru in September and that LRC had passed the "Community Adoption" agreement. It is now in the hands of each legal team to finalise.

**4.\*Community Defibrillators** GM reported that the school defibrillator will stay inside of the school. This is due to a defibrillator being fitted to the outside of the pub.

**5. \*Community Centre Parking** GM reported that the community centre car park is being used for private parking by local residents. This has been reported to Llanelli Rural Council for action.

**6.\*Road Markings** GM agreed to chase this up. Still no action on Heol Nant road markings.

**7. \*Benches at top of ravine.** Agreed for AV to proceed with picnic bench purchase. General agreement that this item will be pursued early next year.

**8.Christmas Tree** The agreed date for the lights switch-on is Thursday November 28<sup>th</sup> 2019 at 6.45pm.

1) GM confirmed that SV School is aware of the date and time of the switch-on and that the Headteacher will switch the lights on and pupils will sing at the event.

2) GM to finalize public liability insurance. AT to arrange electrical safety certificate before 28/11/19.

3) GM confirmed that the sound system has been arranged.

4) GM confirmed that the road closure has been arranged. GM reported that he has been unable to obtain road cones. SJ offered red & white warning tape that may be strung between appropriately parked cars.

5) MD reported that 12 raffle prizes have been purchased for £32 and that various gifts have yet to be obtained.

6) VH confirmed that raffle tickets are available.

7) DK reported that 3 x 1000 'blue' lights have been purchased for the 'tree' centre pole and fence, giving a total of 11000 lights for the display.

8) AT confirmed that Sheds'n'Challets will site Santa's grotto at about 9.30am on Thursday 28/11/19 and that the cost is £102.00. AT also confirmed that Sumanan will supply sweets for children visiting Santa.

9) DK stated that he will provide his lights for Santa's grotto but asks that **any Committee Member** who has lights that they are willing to add to make the grotto more spectacular should make this known at the next meeting.

10) MD confirmed John Evans availability to act as Santa.

11) JD reported a successful 'dummy run' to erect the treeless Christmas lights.

12) DK /GM to arrange collection of the picket fence from the Community Centre on the morning of 23/11/19.

13) It was agreed that the 'tree' will be erected on Sunday 24<sup>th</sup> November at 10.00am - **All available to attend.**

14) Santa's grotto to be decorated on at 10.00am on 28/11/19.the morning of 28<sup>th</sup> November at 10.00am. **All available to assist.**

**9.\*Playground Mural** GM commented that this was ongoing subject to neighbour agreement.

**10. Items for review as necessary:-** Shop Frontage, School related 20mph limit, Noise from Camford, Toxic waste - Llangenech, Quarry processing plant.

**11. Association Christmas Meal** - It was agreed the annual Christmas dinner would be held in the Tafarn-Y-Felin pub on Monday 9<sup>th</sup> December '19 . GM confirmed that a table has been booked.
